

## NJ ASPHALT PAVEMENT ASSOCIATION JULY 2024 MEMBER UPDATE

NJDOT Achieves Record Year of Contract Awards for Fiscal Year 2024, Asphalt Tonnage Up 44% over FY2023

NJDOT ended Fiscal Year 2023 with \$1.245 million in project awards, including \$448 million in paving specific contracts. NJDOT awarded 115 contracts including 46 pavement projects, the largest number since FY2019. Overall, NJDOT awarded 1,283,698 asphalt tons, a 44% increase over FY2023 and the highest tonnage total since FY2021. NJAPA thanks and commends all of the staff at NJDOT for working diligently to get this level of work bid and awarded.

Governor Phil Murphy Announces Tim Hillman as new Chief of Staff, Diane Gutierrez-Scaccetti to remain as Senior Advisor

New Jersey Governor Phil Murphy has announced that his Chief of Staff, Diane Gutierrez-Scaccetti, will depart her current position and transition to a new role as a senior advisor. Principal Deputy

Chief of Staff Tim Hillmann will assume the role of Chief of Staff later this Summer.

In a statement announcing the moves, Murphy said, "Diane Gutierrez-Scaccetti has done an outstanding job as my Chief of Staff over the past year. From negotiating a reauthorization of the Transportation Trust Fund to successfully enacting a Fiscal Year 2025 budget with our partners in the Legislature, Diane has brought a wealth of knowledge, experience, and expertise to our team. I've asked her to continue serving our Administration as a senior advisor to help troubleshoot some of our most pressing and challenging operational challenges – such as large-scale infrastructure projects and complex interdepartmental initiatives. I thank Diane for her service as Chief of Staff and look forward to her continuing to play a senior role on my team."

## OSHA Announces Proposed Rule for Heat Injury and Illness Prevention in Outdoor and Indoor Work Settings

OSHA is issuing a Notice of Proposed Rulemaking (NPRM) for Heat Injury and Illness Prevention in Outdoor and Indoor Work Settings. This is a significant step toward a federal heat standard to protect workers. The proposed standard would apply to all employers conducting outdoor and indoor work in all general industry, construction, maritime, and agriculture sectors where OSHA has jurisdiction.

The proposed standard would require employers to develop a Heat Injury and Illness Prevention Plan, track and monitor heat conditions and implement certain control measures above 80 degrees and additional control measures above 90 degrees.

Once the rule is officially published in the Federal Register, industry and the public will have an opportunity to submit comments.
